The Board sincerely thanks the retiring General Secretary, John B, for his consistent commitment and knowledge shared during his long service on the Board and as Convention Chair in the absence of a RBM. We wish to acknowledge Cheryl D for her contribution on the Board and willingness to serve in the future.

The result of the KBDM eMessenger Trial was that the eMessenger will not continue. Sadly this is due to not enough sharings from the fellowship to make it sustainable. A big thank you to the eMessenger Trial Committee Chair, Renee and her Committee for their enthusiasm, and production of a professional publication that the fellowship enjoyed tremendously. The position of Editorial Chair remains vacant with resources available if requested.

The Board is concerned that the Regional Board Members (RBM)s are not filled. The Areas are responsible for filling these roles to ensure the Board gets a national focus, they also know what is happening in their Areas which is a valuable resource to the Board and the fellowship. Attached is more information on these roles.

The Board delegated authority to the Executive Budget Committee to spend up to \$10,000 from the Reserve Fund to refresh the GSO office furniture, equipment and environment.

We are excited to have been invited back to attend this year's Cutting Edge Conference hosted by Dapaanz to be held at The Dunedin Centre, Dunedin on the 9-10 September 2021. Volunteers will be required to man our exhibit stand. Please contact Tracy to volunteer.

Motions approved at the 2021 NZASC:

- 1. That the 2020/2021 annual financial accounts be accepted.
- 2. That the 2021/2022 annual budget be accepted.

In reference to the Informal Literature Committee Report to March NZAGSB and NZASC 2021.

- 3. We propose that NZASC 2021 formally approve that action (point 2).
- 4. We consequently propose that the best approach is to include in our Handbook hyperlinks to the WSO guidelines wherever significant adaption is not strictly necessary (point 3).
- 5. In each case we recommend to NZASC 2021 that the above guidelines be removed from the KN-17 and reference to it be deleted from the KN-17 Contents document (point 4).
- 6. We will amend the handbook to remove reference to "P90" and retain reference only to 'Best of Public Outreach" (point 4).
- 7. That the NZASC 2021 approves removal of the following guidelines from the NZ Al-Anon Service Guidelines (KN-17) and the deletion of reference to each of those guidelines in the KN-17 Contents document (point 7).
- 8. That the NZAGSC give Traditional Approval for roles presented by the NZAGSB.
- 9. That the current Editorial Chair role remain in the handbook and be reviewed by the Literature Committee to include possibility of an electronic Messenger.
