### IAGSM - October 2022

Our IAGSM Delegates came back from attending the IAGSM in November. Highlights from the meeting include learning how other structures have dealt with working remotely, challenges the worldwide fellowship is having filing service roles, and communication issues at all levels. We have some fresh ideas and will be implementing some of them in the coming year.

The attending members of the World Service Office offered an apology for their lack of communication with structures outside of the USA in the last two-three years as they acknowledged their focus had become very inward as they struggled to deal with pandemic related issues. The amends made is they have now set up an international division allowing structures access to World Service Office members for clarity and information.

We have taken up the offer of regular online meetings with the international team and the first one was held recently. We were able to air our concerns about not having Alateen meetings online and not receiving communications that other structures had access to some time ago. As a result of talks at IAGSM, the World Service Office has invited the New Zealand structure to participate in the online Alateen meeting trial now extended until 2023. As the World Service Office team are taking personal responsibility for this trial, there are a few conditions. The meeting must be only for the Alateen members in the geographical country it is held in and must adhere to that country's legal safety guidelines around child safety. The Alateen sponsors must attend Alateen sponsor meetings, and the group is to answer World Service Office's questionnaire (which we are waiting to receive).

This is a very positive step forward and having regular face to face contact with World Service Office International team will be extremely helpful. As a Board we look forward to being able to share this communication with the fellowship. We are willing to visit your Area and share our learnings.

## <u>Alateen</u>

With the exciting information above from the World Service Office, the National Alateen coordinator would like to encourage each area to have an Alateen coordinator. With this in mind, we can start the communication for area Alateen coordinators to work alongside the National Alateen coordinator and encourage members to get on board as AMIAS (Al-Anon Member in Alateen Service) to grow Alateen in New Zealand.
